### *What is the RCIA Network?*

The RCIA Network is made up of people who have leadership roles in the RCIA (*Rite of Christian Initiation of Adults*) process in Dioceses and parishes, and exists to support them in their work and to promote an authentic understanding of the Church’s teaching about the Rite.
